

Per Court :-

- 1. We had directed the learned DSGI vide paragraph 7 of our order dated 10.10.2022 to tender the list of those students along with their account numbers, who have received scholarship amounts through direct deposits in their accounts.
- 2. We are aware that such direct deposition of amounts to the tune of Rs.63 crores and odd in favour of two lacs and odd students, is in direct conflict with our order and direction dated 23.03.2022. When we directed that the amounts would not be credited to the accounts of the students considering the controversy before us, the Union of India has distributed Rs.63 crores within seven days after the order of this Court. The Union of India had approached the Honourable Supreme Court against
