1. These matters pertain to the scholarship issue. This Court has passed orders on earlier occasions. The directions issued by this Court vide order dated 5<sup>th</sup> May, 2022 need to be complied with without any exception.

- 2. The learned DSGI submits that the demand drafts payable to individual institutions, have been delivered to him and they can be deposited with the learned Registrar of this Court. He, however, voices a difficulty as to what should be done about those institutions, who are not petitioners before this Court.
- 3. We are of the view that all the litigating parties, inclusive of all those, who have not approached the Court, are bound by the

directions set out in a common order dated 5<sup>th</sup> May, 2022 delivered in Civil Application No.6737 of 2022 and several connected matters. If the Union of India is bound to pay the amounts to the institutions and is depositing the demand drafts of those institutions, who are petitioners before us, the demand drafts with regard to those institutions, which are not before us, can be disbursed as per the directions set out in the order dated 5<sup>th</sup> May, 2022.

- 4. We record the statement that these demand drafts are prepared in the light of the order dated 10<sup>th</sup> October, 2022 passed by this Court.
