Heard the learned Senior Advocates as also learned Advocates, the learned Additional GP and Standing Counsel for Union in respective matters.

2. Learned Addl. GP places across the bar written instructions received from the Government of Maharashtra, *inter alia*, demonstrating scheme framed for sharing the data of the verified applications for the academic year 2022 and 2023 with the Central Government. It is being mentioned that the State though has contributed 40% of its share was unable to push the data through API to the NSP portal. It is also being informed that necessary steps are being taken to co-ordinate with the concerned MoSJE, Government of India.

3. Learned Senior Advocate Mr. Khandeparkar, submits that he has been provided with this communication just now. He assures that instructions would be given to all concerned, so that the communication gap between the relevant departments of Union and the State Government would be sorted out by sitting across and for

coming out of this technical problem, whereby, the data was unable to be shared. He seeks short accommodation to take positive steps.

4. There are several matters which have been filed subsequent to the orders passed by this Court in the group of matters which are pending since long and in which the effective orders have been passed. Learned Advocates for the petitioners in those new matters submit that even these Institutes, in their matters are suffering the same plight. The scholarships have not been disbursed from the academic year 2020-2021 onwards and the Managements are still to get reimbursement of the tuition fees like in the other matters. The Union and the State shall take instructions even in these matters.

5. Wherever in these new matters the notices have not already been issued, those be issued to respondents. Learned Standing Counsel waives service of notice for respondent – Union of India. Learned Additional GP waives service of notice for respondent – State of Maharashtra.
