. Mr. Patel, learned Addl. Govt. Pleader on instruction states that the State Government has already indicated in various affidavits filed in these petitions as to how much amount is payable to the petitioners and/or the students by the State Government and reflected on Maha DBT Portal. He submits that there is no dispute in respect of atleast that much amount which is already reflected on the said portal, due and payable to the petitioner and/or the students. Statement is accepted.

2. Insofar as the balance amount is concerned, the State Government has not reflected the amount on the portal either on the ground of its financial difficulties or on the ground of the petitioners and/or the students who are the beneficiaries of those amount having not complied with certain requirements. If there are any deficiencies in the application made by the petitioners and/or the students for availing the balance amount, such deficiencies should be removed by the petitioners and/or the students within one week from today.

3. Insofar as the amount already reflected in the portal is cornered, the petitioners and/or the students who are entitled for such amount shall be disbursed that amount on or before 26<sup>th</sup> August, 2021 without fail. Learned Addl. Govt. Pleader to make statement and confirm before this Court about the compliance of this order on the next date. Learned Addl. Govt. Pleader shall also make a statement as to when the balance amount due and payable to the petitioners and/or the students as the case may be, would be indicated on the portal and would be disbursed by the State Government, on the next date. State Government shall also file affidavits in the matters in which no affidavits are filed till date in compliance of the order dated 11<sup>th</sup> August, 2021. State Government shall consider the issue of mapping raised by the petitioners in all these petitioners as more particularly highlighted in the chart tendered before this Court today. Such affidavit shall be filed within one week from today.

4. We hope that the order passed by this Court today would be complied with by the State Government and would not compel this
