GP for the State and if any further amount is due and payable according to the petitioners, then the same shall be placed on record by filing an affidavit to that effect by serving a copy of the same on the learned Addl. GP before the next date.
- 4. Place the matter for directions on 27th September, 2021 "High on Board".
